

QMT Car Park Terms and Conditions

1. Entry to or use of this car park is subject to these terms and conditions which you (the term "you" means any user of the car park) expressly agree and/or are deemed to accept when you enter the car park.
2. Qur'ani Murkuz Trust (hereinafter called "QMT", which term includes its trustees and the members of the service committee) and its servants or agents reserve the right to refuse admittance to the car park.
3. The car park is exclusively for the use of QMT centre users on Fridays and such other periods or days as QMT may determine and by others at other times. The car park is open during those times and dates as determined by QMT. Cars must not be left overnight and if they are you will incur a fine of £100 per night.
4. **Entry to, use, parking and exit from the car park is entirely at your own risk.** Please drive carefully and obey the directional signs. Vehicles should not be driven at a speed in excess of 5 miles per hour. Customers must not cause obstruction.
5. You must pay the car parking fee (as advised from time to time). Failure to do so will render you liable to pay a full day's fee plus any administration charge as set by QMT from time to time but which is currently £20. Payment of a fee or a ticket (including a season ticket) does not entitle you to any space in the car park or to priority over other users.
6. **QMT will not and does not guarantee the security of your vehicle or its contents.** Accordingly QMT, its servants or agents, will not accept liability in respect of any loss or theft of or from or damage to any vehicle or its contents howsoever caused and QMT, its servants or agents, will not accept liability howsoever caused in respect of the death or of personal injury sustained by customers and others in the car park.
7. Should your vehicle suffer damage whilst in the car park or should you lose the vehicle or any of your possessions from the vehicle whilst it is in the car park, you are requested: (for information purposes only and not because of any liability – which is excluded under these terms) to immediately inform a member of the QMT staff and also; in case of theft and immediately to inform the Police.
8. If a breach or infringement of any of these terms and conditions is committed by you then QMT or its servants or agents may at any time in their absolute discretion request you to remove your car from the car park and/or (if permitted by law) immobilize any vehicle by means of a clamp fitted to a wheel of the vehicle. The clamp will be removed upon payment of a charge as determined from time to time by QMT. QMT its servants or agents will not be liable for any damage caused to a vehicle as a result of a clamp having been fitted to the wheel of the vehicle, other than that which is attributable to wilful misconduct on the part of QMT.
9. QMT reserves the right where these terms have not been complied with or the car park has to be closed either permanently or temporarily in whole or in part or have to be evacuated in cases of emergency, without any liability for loss or damage to remove any vehicle at any time and take/drive/push/tow it to the public highway.
10. A vehicle in the car park will be subject to a lien for all charges due or accruing from the customer to QMT, and a general lien for all and any monies from the customer to QMT, such lien to be in existence whenever the vehicle is in the car park.
11. You agree to indemnify QMT in respect of any claim by a third party arising out of the use of the car park by you, your servants, agents or passengers or arising out of any act or omission whatsoever.
